RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE CONTRACT, THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.14 (DIRECT RETAIL PURCHASE), FOR THE PURCHASE OF ROUNDTRIP AIRLINE TICKETS FOR 5 EMBASSY OFFICIALS WHO WILL BE ATTENDING THE CONSULAR AND ECONOMIC CONSULTATIONS AMONG PHILIPPINE POSTS IN CANADA

WHEREAS, the Philippine Ambassador to Canada, H.E. Maria Andrelita S. Austria, accompanied by 4 other Embassy Officials, intends to attend the annual Consular and Economic Consultations among Philippine Posts in Canada in Vancouver on 13-16 December 2024, which necessitates the purchase of roundtrip airline tickets;

WHEREAS, the aforementioned activity / expense item is included in the Embassy's Annual Procurement Plan for Fiscal Year (FY) 2024;

WHEREAS, Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act of 2003" and its Implementing Rules and Regulations (IRR) prescribes the procedure to be followed by the procuring entities in their procurement activities to promote transparency, accountability, equity, efficiency and economy;

WHEREAS, Section 53.14 of the 2016 revised IRR of RA 9184 allows an agency to resort to direct retail purchase of airline tickets from any commercial airline at fairly reasonable rates, subject to flight availability at time of booking, travel days, stopovers, routes, additional visa requirements and other reasonable considerations as determined by the end-user;

WHEREAS, in the interest of performing due diligence, the Bids and Awards Committee (BAC) of the Embassy secured quotations, inclusive of taxes and fees, from the following airlines:
