BAC Resolution No. 85 - 2024

RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT UNDER SECTION 53.9 FOR THE PROCUREMENT OF TWO (2) 65-PIECE FLATWARE SETS

WHEREAS, the Embassy of the Philippines in Ottawa intends to procure two (2) 65-piece flatware sets for use during official events and functions it organizes or hosts;

WHEREAS, the procurement of the aforementioned subscription is included in its Project Procurement Management Plan (PPMP) for Fiscal Year 2024;

WHEREAS, Republic Act (RA) No. 9184, otherwise known as the “Government Procurement Reform Act of 2003” and its Implementing Rules and Regulations (IRR) prescribes the procedure to be followed by the procuring entities in their procurement activities to promote transparency, accountability, equity, efficiency and economy;

WHEREAS, it is the policy of the government that procurement of infrastructure projects, goods and consulting services shall be done through Competitive Bidding except as provided for in Article XVI or RA 9184;

WHEREAS, Section 53.9 of the 2016 revised IRR of RA 9184 allows an agency to resort to Small Value Procurement as an alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribe in Annex “H” thereof;

WHEREAS, the Bids and Awards Committee (BAC) of the Embassy secured quotations, exclusive of applicable taxes and fees, from the following service providers:

1. Bed Bath & Beyond – CA\$ 555.40
2. Wayfair – CA\$ 659.98; and
3. Amazon – CA\$ 794.00;

NOW, THEREFORE, we the members of the Bids and Awards Committee of the Philippine Embassy in Ottawa **RESOLVED** to **RECOMMEND** to the Ambassador and Head of Procuring Entity (HOPE) the resort to Small Value Procurement under Section 53.9 as the alternative method of procurement of two (2) 65-piece flatware sets from Bed Bath & Beyond for the retail price of Five Hundred Fifty-Five and 40/100 Canadian Dollars (CA\$ 555.40), exclusive of applicable taxes and fees, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed.
