RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE CONTRACT, THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT), THE PROCUREMENT OF NEW LED LIGHT BULBS FOR THE OFFICIAL RESIDENCE

WHEREAS, the Embassy of the Philippines in Ottawa needs to procure replacements for the busted light bulbs at the Official Residence;

WHEREAS, the aforementioned expense is included in its Annual Procurement Plan (APP) for Fiscal Year (FY) 2024 under Other Supplies;

WHEREAS, Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act of 2003" and its Implementing Rules and Regulations (IRR) prescribes the procedure to be followed by the procuring entities in their procurement activities to promote transparency, accountability, equity, efficiency and economy;

WHEREAS, Section 53.9 of 2016 Revised IRR of R.A. 9184 allows an agency to resort to Small Value Procurement as an alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (PHP1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Bids and Awards Committee of the Philippine Embassy in Ottawa received quotations, inclusive of applicable with taxes and fees, from the following retail providers:
