BAC Resolution No. 98 - 2024

RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF CONTRACT, THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT), FOR THE PURCHASE OF THREE (3) WATER JUG RACKS

WHEREAS, the Embassy of the Philippines in Ottawa intends to procure three (3) water jug racks to optimize the space where they are currently being stored;

WHEREAS, the procurement of the aforementioned subscription is included in its Annual Procurement Plan (APP) for Fiscal Year 2024;

WHEREAS, Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act of 2003" and its Implementing Rules and Regulations (IRR) prescribes the procedure to be followed by the procuring entities in their procurement activities to promote transparency, accountability, equity, efficiency and economy;

WHEREAS, it is the policy of the government that procurement of infrastructure projects, goods and consulting services shall be done through Competitive Bidding except as provided for in Article XVI or RA 9184;

WHEREAS, Section 53.9 of the 2016 revised IRR of RA 9184 allows an agency to resort to Small Value Procurement as an alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribe in Annex "H" thereof;

WHEREAS, the Bids and Awards Committee (BAC) of the Embassy secured quotations, inclusive of applicable taxes and fees, from the following retailers:

- 1. Amazon Canada CA\$ 156.58;
- 2. Wayfair CA\$ 189.81; and
- 3. Bed, Bath, and Beyond CA\$ 252.62;

NOW, THEREFORE, we the members of the Bids and Awards Committee of the Philippine Embassy in Ottawa RESOLVED to RECOMMEND to the Ambassador and Head of Procuring Entity (HOPE) to resort to Small Value Procurement under Section 53.9 as alternative method of procurement of three (3) water jug racks from Amazon Canada for the retail price of One Hundred Fifty-Six and 58/100 Canadian Dollars (CA\$ 156.58), inclusive of applicable taxes and fees, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed.
