- Requirements:
1. Two recent ID photos (passport size, colored with white background) showing full front view of face;
  2. Photocopy of latest Philippine passport or other documents evidencing Philippine citizenship;
  3. Copy of travel itinerary or airline tickets, which must show direct travel to the Philippines;
  4. Copy of proof of immigration status in Canada (e.g. PR card, work permit, study permit, visa, etc.);
  5. Copy of deportation/removal order (if applicable);
  6. Payment of fee C\$ 46.50 or US\$ 30, in cash, bank draft or postal money order payable to the:  
**EMBASSY OF THE REPUBLIC OF THE PHILIPPINES**
  7. For applications submitted by mail, prepaid self-addressed return courier envelope.

**Note:** 1) A Travel Document may only be applied for in emergency situations or urgent cases and should not be used for convenience in order to avoid undergoing the standard passport renewal process; 2) A Travel Document has limited validity and may only be used for one-way direct travel to the Philippines within 30 days from the date of issue.
